UNIFIED LAND DEVELOPMENT CODE (ULDC) PUBLIC TRAINING AMENDMENT ROUND 2015-02 AND AGRICULTURAL RESERVE (AGR) PRESERVE AREA CONTIGUITY REQUIREMENT

The Zoning Division will be conducting a training session for the public on ULDC Amendment Round 2015-02 adopted by the Board of County Commissioners (BCC) on January 28, 2016, effective February 2, 2016; and, Eliminating the Contiguity Requirement for AGR Preserve Areas for a 60/40 AGR Planned Unit Development (PUD) adopted by the BCC on October 26, 2015 and effective December 4, 2015. The intent of the training session will be to familiarize the public with the amendments and respond to any questions.
